# Scottish Government's GP Workforce Survey-Important-Last Day to Contribute

The deadline for the Scottish Government's GP Workforce Survey has been extended to 11<sup>th</sup> August. If your practice has not already done so, we would urge you to please ensure that your survey return is completed and submitted ahead of this deadline.

The information that the survey provides is critical to understanding the state of the profession and SGPC's ability to make the case at a national level for the improved resourcing and support that general practice so urgently needs. Last year's survey revealed that while GP headcount may have increased, whole time numbers of GPs had fallen – key evidence of the trends that are making our working lives harder and which would not have come to light without practices' submissions to this survey.

For practices who completed the survey last year, the workload involved in taking part this year should have substantially reduced, with last year's data pre-populated and only any changes over the last year needing to be submitted.

# GPs and Practice Managers' Meeting
