1. NE CT Chest pilot

The proposal to extend the CT Chest pilot from the North East across the board area was discussed. Concerns were raised that there is already a good model in the North East which is supported by members from the area. There was also concern about the lack of cancer trackers in this proposal-also for time to treatment for patients.

Covid-19

20/66

1. Community Pathway Update

Case numbers are down and the figures for those attending the CACS are showing indications of settling. There is a clear need to maintain the pathway whilst facilitating the management of the decrease in attendances at the CACs. No decisions have been taken on this yet.

2. Covid-19 Vaccinations

Dates for the delivery of vaccines to permit second doses to agreed practice cohorts have been sent to practices. Board arrangements for delivery within community clinics is progressing well. The portal for unpaid carers to register is now live.

1. GP Subcommittee Leadership Engagements

The Covid Operations group is now meeting only on a Tuesday, rather than twice a week. GP Subcommittee leadership continues to engage in all key Covid and other board groups.

2. <u>Presentation on Board's Mobilisation Plan-Scott Davidson, Deputy Medical Director for Acute & Dr Kerri Neylon, Deputy Medical Director for Primary Care</u>

A presentation was provided by Dr Scott Davidson on the board's mobilisation plan. Dr Davidson, Dr Neylon and Susanne Millar thereafter answered questions from the committee. The issues highlighted are summarised below:

- The presentation served to highlight the challenges faced by NHS GGC recovering from the Covid pandemic.
- Big concerns are finances and recruitment/workforce. Before Covid, there were already
 issues with vacancies. Efforts have been ongoing in relation to recruitment in particular
 in the Clyde area.
- With regard to the redesign of urgent care, the aspiration is to direct patients to the
 correct resource first time and avoid redirection. Pathways from general practice to the
 flow hub/MIU are being developed to avoid the need for people for example to phone
 NHS 24 after having seen a GP.
- The importance of public messaging on reasonable expectations of the NHS was underlined.
- The difficulties with the interface between general practice, MIUs and NHS 24 were acknowledged. It was recognised that not everything has gone right and that learning is happening.
- HSCP Urgent Care Resource Hubs-a huge amount of work has gone into these. These are
 to be the out of hours service for health and social care. Susanne Millar is happy to
 provide more information on this matter.
