1. GP Workload Update

There has been a decline in the number of practices participating in the workload survey. Data is available for up to week beginning 6th December and it shows around 110,000-120,000 appointments per week in GGC. There has been an increase in face to face appointments. A communication is coming to practices regarding temporary changes announced by the UK Government. These pertain to fit notes, firearms licences and driving licences. Concerns were raised that the temporary nature of the fit note change may lead to increased work.

Covid-19

21/63

1. Community Pathway Update

Changes to the pathway came into effect at the beginning of December. The guidance document for children that was re-issued with the recent changes to the pathway needs updated. The recent changes to self-isolation rules will also need to be considered with regards to the pathway. The GP Subcommittee will need to be ready to take decisions should the situation surrounding the pathway require it. This could be via an emergency meeting of the executive or of the full committee. There has been an increase in hub cases but this hasn't been seen in the numbers attending the CACs. There was a call for GPs who can assist with staffing the CACs, hub or OOH.

Flu and Covid Vaccination Programme 2021

21/64

Changes were announced to the programme last week. The flu programme is currently paused. It has been made clear that GP practices are not delivering flu vaccines, including in a board meeting with parliamentarians. Pharmacies in GGC are not contracted to deliver flu vaccines.

PCIP Implementation

21/65

1. PCIP Oversight Group, 16th December 2021

An oral report was provided on this meeting. Many topics were covered at the meeting included: transitional/sustainability payments; the tendering process for travel vaccinations (noting that the direction of travel for the 2018 Contract is for this workload to come out of GP practices); the physio service; CTAC-work is being done regarding the need for an acute phlebotomy service but this must be in parallel, not funded via PCIP nor taking away capacity from general practice, producing a mutually beneficial service (paper will go to the GP Subcommittee in January); welfare and support of CTAC staff within practices.

Out of Hours GP Service

21/66

If GPs have additional capacity, they are encouraged to work in the out of hours service. Rates have been raised for over the festive period. Members heard that OOHs staff are going above and beyond with a huge volume of calls and high workload pressures.
