## **GP Practice Workload & Sustainability**

## 22/76

- There are six practices at level two escalation; 189 at level 1b and 33 at level 1a.
- 15 practices have closed lists.
- The office is receiving reports of extremely high workloads from practices. 28<sup>th</sup> December was a particularly busy day for practices.
- The requirements around extended hours were suspended before Christmas, following a request from the LMC to the board.
- Practices escalating allows for the pressures that practices are working under to be easily visible to the board and HSCPs. Escalation levels are fed back to the Scottish Government.
- Requests regarding escalation should be handled sensitively by HSCPs.
- Concerns were raised regarding negative media reports of GP.

#### **PCIP**

#### 22/77

- Following the resignation of Dr Hilary McNaughtan, the medical directors are going to lead on the CTAC workstream for the time being.
- The medical directors will give consideration to a new lead for Glasgow City HSCP.

#### **Sessional GPs**

#### 22/78

- The LMC is planning its next sessional GP development day and is looking to do this in person again.
- It is hoped that the board will support the LMC with this as it previously has.

## 22/79

- 1. Respiratory MCN, 7<sup>th</sup> December 2022
- This paper was noted by the GP Subcommittee.
- 2. <u>Cervical Screening Steering Group, 8<sup>th</sup> December 2022</u>
- Concerns were raised regarding the waiting times for colposcopies which is up to 52 weeks.
- The national cervical screening group does not believe that a second smear is required whilst a patient is on the waiting list.
- 3. Referral Management Group, 13<sup>th</sup> December 2022
- The GP Subcommittee did not believe it was necessary for GPs to be able to refer to optometry. Patients can be signposted there if necessary.
- Long Covid AHP service-the secretariat has already fed back that this does not need to be piloted and that it is content for it to proceed.
- The vaccination SCI form is for ad hoc vaccinations, so that GPs can advise what vaccinations are required.
- The name and remit of the Referral Management Group was discussed. This is already being looked at by the board.

- 5. Pharmacotherapy and Primary Care: Prescribing Management Group, 15th December 2022
- The example of a practice's pharmacy work will be being shared amongst pharmacy teams.
- 6. Psychotropic Drug Monitoring Group, 12th January 2023
- Concerns were raised about the proposal for monitoring of patients on psychotropic drugs to lie with primary care.
- It was noted that unlicensed drugs would be part of this work.
- Monitoring the side effects of these drugs is outwith many GPs' expertise.
- The GP Subcommittee was of the view that this monitoring should be undertaken by secondary care.

- 1. Respiratory Outpatient Pathways
- The document was seen as more of an educational resource than pathways.
- Concern was however raised that this would lead to a tick box type exercise for GPs.
- Spirometry being a step in the document for primary care was believed to be inappropriate.
- It would be better for the GP Subcommittee/primary care was more involved in the drawing up of any documents affecting general practice.
- Action Point: Feed back GP Subcommittee's views.
- 2. Menopause Referral Pathways & Menopause Testosterone Prescribing Advice
- The menopause referral pathways document was felt to be a useful document.
- The advice email address was seen to be a good facility.
- The FAQs needs to clarify if it is gynaecology or Sandyford that patients should be referred to.
- The prescribing advice was felt to be useful for GPs who are prescribing testosterone. However, it was felt that not all GPs are content to prescribe this.
- Concern was raised regarding the following statement: "If testosterone is deemed appropriate
  by the specialist, it is your responsibility to prescribe and monitor as per the attached
  guidelines."
- It is the prescriber's decision as to whether to prescribe a medication.
