**GP Practice Workload & Sustainability**

**22/88**

- The most recent NHS GGC GP sitrep shows:
  - 182 practices at level 1a of the escalation framework
  - 42 practices at level 1b
  - 4 practices at level 2
  - 12 practices with closed lists.
  - These numbers are currently relatively static.
- It was reported at the Area Medical Committee on 17<sup>th</sup> February that challenges in secondary care do seem to be reducing.
- There are some practices experiencing significant difficulties but others do appear to be seeing some of the workload challenges easing.
- Some members felt that the baseline for a normal workload had increased.
- Concerns were raised regarding unagreed workload shift from secondary care/Sandyford, and having to manage patients on waiting lists for these services.
- The board is keen to have a productive primary-secondary care interface group.
- The GP Subcommittee feels that there are existing good principles regarding this interface.
- A recent press story on the GP out of hours service was felt to not have provided a full picture of the service.
