1. This Circular provides information for GP practice teams about the new NHS Pharmacy First Scotland service.

Background

- 2. The Scottish Government's Programme for Government 2018/19 included the commitment:-
 - We will build on the learning from the extended Minor Ailment Service pilot in Inverclyde and the rollout of the Pharmacy First initiative developing and implementing redesigned minor ailment and common conditions service available to all in the coming year.

3. The current Minor Ailment Service will be discontinued and replaced by the new NHS Pharmacy First Scotland which comes into force in community pharmacies as of 29 July 2020.

Details

- 4. The NHS Pharmacy First Scotland service seeks to encourage people to go to their local pharmacy for support with minor and acute health conditions. It extends access to a wider group of people than those who were able to use the Minor Ailment Service. Individuals who are registered with a GP practice in Scotland, or who live in Scotland, will be eligible to use NHS Pharmacy First Scotland subject to certain exceptions for visitors to Scotland.
- 5. Pharmacies will undertake an NHS Pharmacy First Scotland consultation and provide advice, treatment or referral to another healthcare professional if appropriate. As well as minor conditions, it will also continue to provide advice and treatment for specific common clinical conditions, starting with uncomplicated UTIs in women and impetigo. Further common clinical conditions will be identified and added in due course.

- 7. Discussion between GP surgeries and their local pharmacies is strongly encouraged to develop ways of working which take local needs into account, whilst ensuring a safe and efficient patient journey.
