ew Scottish GP Contract

SGPC and Scottish Government are in the final stages of negotiating the new Scottish GP Contract which will replace the current 2004 GMS Contract. Talks should be concluded by November and the Contract Framework document should be published shortly afterwards. There are national BMA Roadshows planned for November and the Special Scottish LMC Conference will be held on 1st December allowing LMCs to discuss and debate the new Contract.

It will be a practice based Contract and will include-

- The GP as the Expert Medical Generalist in the community- dealing with undifferentiated illness, complex problems and leading the enhanced healthcare team.
- Moving services such as immunisations, phlebotomy and treatment room out of the GP contract with no reduction in GP practice income.
- Direct reimbursement of practice expenses
- Reducing the risks of owning and leasing premises for GPs
- Promoting the GP partnership model of Scottish general practice
- Reducing GP workload with an expanded multidisciplinary primary care team including pharmacists, MSK physios, mental health workers, links workers and community paramedics
- GPs as clinical leaders and GP practices working in clusters to influence the delivery and quality of patient services

ational Primary Care Workforce Survey 2017 There is ANOTHER workforce survey that is going now! This is a national survey run by ISD Scotland. There will be a payment of £150 per practice for completing the survey which will come through the December schedule. The original deadline was 30th September but due to the low response rates, this has been extended to mid-October. Please participate!

cickness Leave Payment

We have had many enquiries from practices about the change to the Scottish Statement of Financial Entitlement (SFE) for 2017/18 relating to payments for locums covering sickness leave [Section 81.

The key points to remember are:-

- The SFE reimburses locum costs to cover for the absent GP. This can be for external or internal GP locum cover.
- No reimbursement is payable for the first 2 weeks of absence.

- The practice must contact the Health Board as soon as possible to inform them of the locum costs and cover required.
- The maximum payable is £1,734.18 per week; or the actual cost of the locum if lower than the maximum.
- Full amount is payable for 26 weeks and then a further 26 weeks at half the full amount.
- Practices claiming for costs during a month must do so by the 10th day of the following month.
- Inform the Health Board if there are any significant changes to the cover arrangements
- There is no reimbursement if no actual locum cover was engaged.

GPs are reminded that it is important to review their partnership agreements in light of the sickness leave payment changes.

The LMC is unable to give any advice to GPs in relation to locum insurance policies or personal health insurance. We would advise that GPs get independent financial advice about their own circumstances and how the changes in sickness leave payments in the SFE will affect them.

odernising Out-patient clinics

We are aware of changes that have been happening in some hospital departments in the way that patients are followed up by out-patient clinics. There is no doubt that due to pressures on services and **The Modern Outpatient** agenda, pathways for patients will change and there will be more emphasis on

community rather than hospital based follow up.

We are engaging with the Board and secondary care colleagues via the Interface Group in discussion about future pathways. However, we would ask GPs to be alert to any current unresourced and non-agreed work being passed to primary care such as continued longer term monitoring or specialist level management of patients. Please get in touch with the LMC if you have experience of this.

nadequate Contact Details on Letters

We are still hearing of instances of inadequate or lack of contact details on hospital or community clinic letters. This is especially for hand written letters from clinics for medication start or changes. GPs need to know where each letter has come from and who the clinician was. In addition, lack of information makes it difficult to contact the clinician involved to clarify issues. If you have example of this, please let us know.

MC Workforce Survey

A big thank you to everyone who took part in our workforce survey over the summer. We had over **90%** of practices responding which is an amazing return. We are currently analysing the results and will present the survey to the LMC committee in October.

off The GMS eHealth Steering committee has approved the ending of paper Microbiology results to practices.

This followed a successful pilot in a number of practices to prove that the EDT feed was correct and reliable, with no discrepancies found between paper and electronic transfer.

All other lab specialities will continue to send paper results to practices in the meantime.
