#### To All GPs and GP Practices

Welcome to our 34th Covid Newsletter and *Eid al-Fitr Mubarak* to our colleagues who are celebrating this week!

Since our last newsletter on 23rd April, we have gone from Level 4 to 3 and have seen the lifting of some Covid restrictions. Next week, we are due to move to Level 2 which will further open up many aspects of the economy and social interactions.

As we saw last summer, the easing of lockdown restrictions will undoubtedly increase practice workload which are already at levels well above pre-pandemic levels. Therefore, as discussions go on about NHS Recovery and practice de-escalation, we are clear that giving practices the ability to manage their workload and prioritising care will be key.

#### General Practice under severe pressure

GPs and practice managers are telling us about the significant pressures they are under currently. Workload is now at levels not seen previously and this is having an impact on the whole of our workforce in general practice.

We have made sure that SGPC are fully aware of our concerns and the feedback we are getting from our practices.

#### UK LMC Conference

Representatives from LMCs across the UK met online this week to debate the important issues affecting general practice in all 4 nations.

Our LMC representatives spoke of the urgent need for a support and retention package for GPs. We heard about the problems in general practice arising from the pandemic and supported the calls for investment into the NHS to tackle the workload and the long waits for secondary care.

It is clear, hearing from colleagues across the UK, that Governments need to focus on supporting general practice to deal with the 'tsunami' of workload and patient demand.

### **Covid Community Pathway**

The Covid Hub and CACs were established in March 2020 to assist with the Covid-19 pandemic and to provide a streamlined service to patients who were displaying signs of Covid, who were at risk of Covid, or who were self isolating due to Covid-19.

Due to a decrease in demand within the Hub from the peak in January, the Board have taken the decision to reduce capacity where possible within each of them. Greenock CAC was closed on 7th May due to a significant decrease in demand, and other CACs have reduced their GP capacity.

We are engaging with the Board about the future plans for the Covid Community Pathway and to redesign the service in the coming months to reflect any anticipated increase in activity over the Autumn and Winter period.
