Full Committee Reconvenes

The full LMC and GP Subcommittee met virtually this week after the summer recess. Virtual meetings will be the norm for us for the foreseeable future. We discussed the plans for the Community Pathway over winter as well as other major issues including GP workload, the Flu programme, and motions for the Scottish LMC Conference in December.

Covid Pathway and Community Assessment Centres

The Covid Pathway has been operating in GGC since April and it has enabled patients to be assessed whilst keeping GP practices Covid free. Committee members at Monday's meeting expressed strong support in maintaining the national Pathway which includes adults and children. As the second wave hits, the capacity of the CACs will require to be increased to meet the numbers of patients needing assessment. We are committed to working with practices, HSCPs and the wider system to promote the sustainability of the Covid Pathway.

GPs, nurses and admin staff within practices are encouraged to come forward if possible, to provide additional capacity to ensure that the CACs are staffed. Flu Programme

We have had a number of enquiries from GPs and practice managers about this year's flu programme. We have worked together with Primary Care Support in producing a briefing document for GPs to explain the programme in more detail, including the different cohorts, patients from other Board areas, and vaccine ordering. DDRB Visit to GGC

The Doctors' and Dentist Review Body (DDRB) is the organisation that advises governments on doctors and dentist pay in the NHS. The DDRB "came" to GGC virtually this week to speak to doctors about their views on pay and the current pandemic. LMC members attended this virtual session.

The DDRB heard GPs' concerns about the lack of any significant pay rises in the past 10 years which is impacting on take home pay. In addition, pay and morale has been affected by pension changes, increasing workload, and difficulties in recruitment.

Retirement

Mary Fingland is set to retire from her role as Business Coordinator at the end of November. Mary has been with the LMC for 20 years and is well known to many GPs and practice managers. She is a font of knowledge and her experience, dedication to general practice, good humour will be difficult to replace.


